Brief Description of Proposed Action: Tarpon Towers II, LLC. ("Applicant") proposes the installation of an unmanned wireless communications facility located on the existing property. Said property being located off of 7 Woodcrest Lane at the intersection of US Route 9W and Woodcrest Lane. Access to the proposed facility will originate from Woodcrest Lane utilizing the existing gravel access road. The facility will be utilized by the Town of Marlborough, as well as other service providers. In general, the installation will consist of the following: twelve (12) antennas and related equipment mounted on a proposed 90' tall monopole at center-line height of 86'±, cellular equipment at grade within an 1,250 sf fenced lease area, and all related coaxial cabling and utility services (power and telephone). The action is classified as Unlisted pursuant to 6 NYCRR Part 617.4 (SEQRA).
